



Memorandum of Understanding

We are pleased that you have chosen Global Samaritan Resources, Inc. (GSR), to handle the logistics of your humanitarian aid. Your signature below indicates that you understand and further agree to our Pricing Policy and Payment and Storage Terms.

Pricing Policy

- A handling fee is assessed for shipments and may be adjusted based on materials sent or bulk weight of items. Fees are \$100 per pallet, \$1,500 per 20' Container, \$3,000 per 40' Container. For food or air freight shipments, refer to the attached addendums.
- Freight Forwarder quotes are usually door to door (Abilene to destination). Please realize that freight costs can vary.
- Additional domestic freight costs may be incurred.
- Cost of crating materials, express shipment of documents, fumigation and other miscellaneous costs directly incurred in the preparation of your shipment will be included in your final invoice.
- Charges for customs, taxes, border crossings and other extenuating circumstances are not the responsibility of GSR.
- GSR attempts to send high quality goods. However, the consignee (authorized receiver of goods) assumes all responsibility for the in-country distribution/use of goods.

Payment Terms

- The down payment consisting of 50% of the freight quote plus 50% of our handling fee, is due within 14 days of signing the agreement. Failure to make the down payment within 14 days will result in delay of your shipment.
- The remaining balance will be due upon receipt of the final GSR invoice.
- If the Freight Forwarder requires pre-payment of the total amount, the client will be required to pre-pay the invoice.
- Freight Forwarder quote is valid for 30 days, so freight charges may vary.

Storage Policy

- GSR agrees to store goods/materials on your behalf as part of this agreement for up to one year.
- GSR assumes no responsibility to insure a client's stored goods/materials. All liability of goods/materials stored by GSR is thus the responsibility of the client.
- The volume of stored goods/materials is not to exceed that which can be shipped within a 40' container.
- These storage terms are effective for one year from the date of signing this agreement.
- All stored goods/materials become the sole property of GSR if the stored goods/materials remain in our warehouse one year following the date of the agreement ~ OR ~ client may opt into a monthly storage lease agreement.

Note: Exceptions to policy and/or terms must be agreed upon in writing, prior to finalizing this agreement.

Food Shipment Addendum

- GSR has a partnership with a broker who secures fortified dehydrated food specified for qualified NGO's serving other nations.
- Qualifying organizations may take advantage of this relationship. Food shipments incur an additional broker's fee that varies by volume but is typically \$700 per 35-pallet load. Broker's fee for food shipments will be individually quoted and documented here: _____.
- Additional costs for the food inspection and domestic ground transportation is typically incurred and will be added to the final invoice.
- GSR's basic handling fee is reduced by 50% for food shipments.
- All other relevant terms of our Pricing Policy and Payment Terms apply.
